Call to Order: The meeting was called to order by Council Chair Ken McMillin.

Vice President's and Dean's Report – Dr. William Richardson

Leaders in higher education met with Governor John Bel Edwards. There appears to be a \$750 million midyear budget deficit, with \$300 million in tax credits that have been claimed by companies. The budget will be based on numbers, not on contingencies. Higher education cuts are estimated at \$116 million, with \$65 to LSU. Baton Rouge A&M campus share is \$19 million and Ag Center share is \$11.5 million. The cuts will be difficult to absorb in April, May and June of this year. The special 3-week legislative session begins February 15 after the Revenue Estimating Committee has presented their report on February 10. There is a \$1.9 billion deficit anticipated for FY 2017 that may grow to \$2.1 billion. The legislative regular session cannot do revenue this year so all financial matters will have to be done in special session. There may be other special sessions between mid-February and June with a push for longer term outlook for financial structure. Cigarette, alcohol, and inventory tax hikes are being considered. A key will be a 1¢ increase in sales tax, which might result in \$380 million. Also to be considered is removal of the federal itemized deductions, about \$750 million. There is the same scenario as last spring, which was 35% reduction over 12 months, but this is different with 32% reduction in the last 90 days of the fiscal year.

The Ag Center will be called upon to generate support in the state. A cut of 10% in dedicated statutory funds would be about \$5 million. The SAVE funds were put into statutory funds last year, not part of the \$11.5 million. The system budgets assembled by the campuses will go to the Board of Supervisors Monday. There will be an internet link to the budget. The Ag Center budget is down 18% over 5 years while main campus budget is up 12%, due to tuition and fee increases.

The incident reported in the press the last two weeks are allegations of misconduct by an Ag Center faculty member, who is presumed innocent until legal proceedings conclude. Auditors are in the Ag Center to determine acceptability or deficiencies in procedures. The faculty member employment perspective will be treated separately from criminal proceedings. The USDA center at Pineville is also receiving scrutiny. The message to unit heads and regional directors is to trust faculty, but verify that policies and procedures are in place and are being followed. These include inventory and equipment usage and leave records. Checking accounts for affiliated organizations, including those for parish foundations, where faculty members have check writing privileges should be moved into university accounts to provide necessary fund oversight.

Business

The December 14, 2015 meeting minutes were approved with after a motion by Dorin Boldor and second by Ioan Negulescu.

Elections were held for Council officers. Ken McMillin was nominated for chair and elected by acclamation. Diane Sasser was nominated for vice chair and elected by acclamation. Kori Myers was nominated for recorder and elected by acclamation. The By-Laws (Article IX section 2) allow two to four additional members, with representation from on- and off-campus Council members. It was discussed and determined that there would be two Executive Committee members for 2016. Ioan Negulescu, Gary Stockton, Cynthia Clifton, and Jeff Davis were nominated for the position. Ioan Negulescu will be the on-campus Executive Committee member and Cynthia Clifton will be the off-campus Executive Committee member.

Reports

Announcements

Faculty Council Election review – Ken thanked Kurt Guidry for all of his efforts in setting up and conducting the election with SurveyMonkey. Two errors in the election were noted. The first was having an initial Renewable Natural Resources ballot for two candidates when one of the nominated candidates had declined because of his retirement. The other was in informing a candidate of being elected when another candidate had received higher numbers of votes. Both errors were corrected and all candidates were satisfied with the election procedure. The success and ease of conducting the election with SurveyMonkey may preclude use of Ag Center Information Technology resources for future Council elections.

PM-11 Supplemental Information – Ag Center employees are expected to file the PM-11 reports of any outside income received in a timely manner because this is a policy and part of employment duties. This includes honoraria, amounts received for expenses above actual costs, and any other income besides university salary. A supplemental information request was sent to current Ag Center faculty members with PM-11 reports on file.

Discussion Items

Important Council Items for 2016 – Ken reminded Council members that Council activities are important and that activities in addition to those listed in the agenda for discussion would be welcomed.

P&T review discrepancies – It was discussed that the differences in evaluations of faculty member dossiers for promotion (and tenure) by units, unit heads, and faculty advisory committee from those of the unit head advisory committee and program leaders is a continuing concern. The job description is a primary element in comparing annual performance and the dossier materials. Discrepancies should be rectified by changes in the job description mutually agreed by the faculty member, unit head, and program leader.

Unit Head Evaluation Committee – There has been no activity of this group in developing criteria for evaluation of unit heads and higher administrators.


Council Representation Review – A chart with additional explanations of the source of Ag Center faculty member distributions and its purpose was distributed. Discussion included the possibility of distance teleconference participation, requirement for physical quorum presence, and minimum number of required in-person attendances.

Annual conference – Without an annual conference, the awards ceremony is sparsely attended, which detracts from the recognition of donors for the awards and from the achievements of the award recipients. Alternatives need to be developed to improve the recognition of this important Ag Center program.

Service Unit Advisory Committees – Some of the committees are active and the status of the others is unknown. Ken will contact Ann Coulon for a current listing of the Service Unit Advisory Committee members and copies of their reports.

A motion to adjourn was made by Dorin Boldor, seconded by Jeff Davis, and unanimously approved.
