Dr. Matt Lee is serving as Chair of LSU Police Department Chief Search Committee and couldn't make the meeting. He provided some comments in email to address the questions below.

1. Administrative/Legislative Update

There are still things that need to be worked out and sorted and it will take a bit before it can be disseminated to the entire organization. Once details become much clearer an organization-wide update communication will be delivered.

2. LSU System/AgCenter Budget Clarification

- a. Break down the budget numbers in depth provided by his email from President Tate. The individual items listed as funded amount to much more than the \$232 million alluded to in the introductory statement. Does that mean some of them are budgeted but may not be realized (the continuing authorization items maybe)?
- b. The investment total is far less than the invested items listed.
- c. What is a continuing authorization for the two building renovations listed?
- d. What is the meaning of the items listed as priority 1, 2, 3, etc.?
- e. Bottom line, how will the *final numbers look to the AgCenter once the BOR and President Tate make priority decisions?*
- f. What is the increase, if any, over our base budget for 2022?

Again, once details become much clearer and organization-wide update communication will be delivered.

3. Global Network shuttered? Are there plans for an AgCenter international administrative function?

The LSU AgCenter Global Network positions wind down on June 30, 2023. Some of those functions will likely devolve to departments if they still want to engage in those activities. Others will take place with International Programs. Low value activities will likely desist.

Dr. Fred Piazza, Chief Information Officer, LSU AgCenter

1. "Pain-Point" Committee formed-LSU AgCenter IT and LSU A&M ITS collaboration for jointly appointed faculty members.

Vinicius Moreira, Mark Schafer, Claudia Husseneder, Nathan Lord, and Evelyn Watts are the council members serving on the LSU AgCenter IT/LSU A&M IT committee to explore ways to help AgCenter staff on campus better connect to LSU A&M services. July 5, 2023, will be the first initial meeting.

Dr. Tara Smith, Executive Associate VP and Director for the Louisiana Cooperative Extension Service

- 1. Question relates to LERS and evaluations conducted this spring. Is there going to be a revision process for rankings of agent performance WITH field agent input.
 - Agent expectations are being reviewed, as mentioned previously. There will be overreaching expectations for all agents with specific program metrics within each discipline. The documents can be shared with the council moving forward. The information is not or will not be anything new but rather serves to bring consistency across the program areas moving forward. To the best of Dr. Smith's knowledge, the evaluation rankings are not slated for revision at this time.
- 2. Is the LSU AgCenter still offering specializations for field agents with accompanying pay increases. Any details will be appreciated, such as how many hours are required, what the pay increase is, what fees employees are responsible for, etc.
 - Specialization will not be offered moving forward. Those currently enrolled in a specialization program will be allowed to complete the process, but no new specialization requests will be approved moving forward. An email update will go out to inform all field faculty of this change.

Ashley Gautreaux, Assistant Vice President; Department, Human Resource Management

- 1. Policy project updates
 - a. No feedback was received on PS 47 (IT Security). It will be posted soon.

- b. Old LCES document on Youth Protection and Youth Development will be revised, modernized, updated, and added as an LSU AgCenter Policy Statement soon.
- c. The first draft PS 42 Promotion and Tenure is not available at this time but will be soon. Mike Salassi and Tara Smith are reviewing it now. Some of the updates to PS 42 include statement on 3-year appointment reviews, departments may appoint a mentor committee changed to must appoint, and expanded guidelines on external reviewers (i.e., external reviewers should not have a relationship with the person under review).
- d. It has been pointed out that the Property and Equipment policy is dated and needs to be modernized. Look for Ashley Gautreaux to start this project on time.
- 2. Ashley Gautreaux reminded the council about the security breach with State of Louisiana OMV. LSU AgCenter offers employees the services of Force ID to help with identity theft issues. An email will be sent out to all employees to inform them about this service. You can enroll at any time. No need to wait for enrollment period.
